WE THE UNDERSIGNED NATURAL PERSONS OF THE AGE OF EIGHTEEN [18] YEARS OR MORE, ACTING AS INCORPORATORS UNDER THE RHODE ISLAND NONPROFIT CORPORATION ACT, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THE CORPORATION IS THE DOWNTOWN PASCOAG ASSOCIATION, AND ITS DURATION SHALL BE PERPETUAL

ARTICLE II

THE PURPOSES OF THIS CORPORATION ARE AS FOLLOWS

1. TO ENGAGE IN EDUCATION AND CHARITABLE ACTIVITIES. THE PROPERTY, ASSETS, AND NET INCOME OF THE CORPORATION SHALL NERER INURE TO THE OF ANY INDIVIDUAL.
