The specific purpose or purposes for which the corporation is organized are:

THE FOUNDATION IS ORGANIZED EXCLUSIVELY AS A PRIVATE FOUNDATION FOR RELIGIOUS AND CHARITABLE PURPOSES, INCLUDING BUT NOT LIMITED TO SPREADING CHRISTIAN TEACHINGS AND PROVIDING FINANCIAL AID, FOOD, CLOTHING, AND EDUCATIONAL RESOURCES TO UNDERPRIVILEGED COMMUNITIES IN THE DOMINICAN REPUBLIC. AS A PRIVATE FOUNDATION, IT WILL USE ITS RESOURCES TO FUND INITIATIVES AND GRANTS TO SUPPORT INDIVIDUALS, ORGANIZATIONS, AND PROJECTS THAT ALIGN WITH ITS MISSION TO IMPROVE LIVING CONDITIONS, PROMOTE SELF-SUSTAINABILITY, AND ALLEVIATE POVERTY AMONG VULNERABLE POPULATIONS. ALL ACTIVITIES OF THE FOUNDATION SHALL BE CONDUCTED IN A MANNER THAT REFLECTS AND UPHOLDS CHRISTIAN VALUES AND TEACHINGS.

#### **ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE CORPORATION SHALL BE MANAGED BY A BOARD OF DIRECTORS CONSISTING OF AT LEAST 3 MEMBERS. THE BOARD SHALL HAVE AUTHORITY TO OVERSEE THE FOUNDATION'S OPERATIONS, FINANCES, AND STRATEGIC DIRECTION.
