

- 2. A motion was made and passed to distribute the financial assets of the Corporation as follows:

75 percent to Lively Faith Ministries, Exeter, RI

20 percent to Harmony Women's Care, Providence, RI

5 percent to The Ministry Training Network of Southeastern New England, Exeter, RI

The distribution of financial assets in accordance with the above plan was completed as of February 26, 2025.

Additionally, most of the physical furnishings and materials of the church were donated to Lively Faith Ministries, with a small number of items donated to the Rocky Hill Grange, East Greenwich, RI and to Trinity Lutheran Church, Ashaway, RI.
