**2. A motion was made and passed to distribute the financial assets of the Corporation as follows:**

**75 percent to Lively Faith Ministries, Exeter, RI**

**20 percent to Harmony Women's Care, Providence, RI**

**5 percent to The Ministry Training Network of Southeastern New England, Exeter, RI**

**The distribution of financial assets in accordance with the above plan was completed as of February 26, 2025.**

**Additionally, most of the physical furnishings and materials of the church were donated to Lively Faith Ministries, with a small number of items donated to the Rocky Hill Grange, East Greenwich, RI and to Trinity Lutheran Church, Ashaway, RI.**
