**Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Bliss Homestead Homeowners Association

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

TO OPERATE AS A NONPROFIT HOMESTEAD HOMEOWNERS ASSOCIATION.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

1.) NONPROFIT STATUS: THE CORPORATION SHALL BE OPERATED AS A NONPROFIT HOMEOWNERS ASSOCIATION UNDER RHODE ISLAND LAW.

2.) MEMBERSHIP & VOTING: MEMBERSHIP IN THE ASSOCIATION SHALL BE AUTOMATIC AND MANDATORY FOR ALL PROPERTY OWNERS.

3.) BOARD OF DIRECTORS: THE AFFAIRS OF THE CORPORATION SHALL BE MANAGED BY A BOARD OF DIRECTORS APPOINTED AS SET FORTH IN THE BYLAWS.
