(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rainbow Village RI

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF THIS RAINBOW VILAGE RI IS TO PROVIDE SAFE, SUPPORTIVE, AND
AFFIRMING HOUSING FOR LGBTQ+ INDIVIDUALS IN RECOVERY. THROUGH
COMMUNITY
LIVING AND PEER SUPPORT, WE AIM TO FOSTER STABILITY, PERSONAL GROWTH,
AND
LONG-TERM RECOVERY."

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE CORPORATION SHALL OPERATE EXCLUSIVELY FOR CHARITABLE PURPOSES
WITHIN THE
MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. NO PART OF THE
CORPORATION'S NET EARNINGS SHALL INURE TO THE BENEFIT OF ANY PRIVATE
INDIVIDUAL. UPON DISSOLUTION, ANY REMAINING ASSETS SHALL BE DISTRIBUTED
TO A
NONPROFIT ORGANIZATION QUALIFYING UNDER SECTION 501(C)(3). THE
CORPORATION
SHALL INDEMNIFY ITS DIRECTORS AND OFFICERS TO THE FULLEST EXTENT
PERMITTED BY
LAW.
