The specific purpose or purposes for which the corporation is organized are:

TO ESTABLISH AND OPERATE A NONPROFIT EDUCATIONAL MUSEUM DEDICATED TO THE

COLLECTION, CONSERVATION, AND EXHIBITION OF FINE TRIBAL AND ETHNOGRAPHIC ART FROM AFRICA,

ASIA, OCEANIA, AND THE AMERICAS. THE MUSEUM OF FINE TRIBAL ART WILL PROMOTE INTERCULTURAL

<u>UNDERSTANDING, HISTORICAL EDUCATION, AND GLOBAL CITIZENSHIP BY</u> CURATING PUBLIC

EXHIBITIONS, EDUCATIONAL PROGRAMMING, LECTURES, COMMUNITY PARTNERSHIPS, AND CULTURAL

HERITAGE OUTREACH INITIATIVES.

EXPERIENCES CENTERED AROUND

THE CORPORATION SHALL HAVE A BOARD OF DIRECTORS WITH A MINIMUM OF THREE (3)

MEMBERS.

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT

OF, OR BE DISTRIBUTABLE TO, ITS DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO

PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS IN

FURTHERANCE OF THE EXEMPT PURPOSES SET FORTH IN ARTICLE III.

<u>UPON DISSOLUTION, ANY REMAINING ASSETS SHALL BE DISTRIBUTED TO ONE OR MORE</u>

ORGANIZATIONS RECOGNIZED AS TAX-EXEMPT UNDER SECTION 501(C)(3) OF THE

INTERNAL REVENUE CODE AND WHOSE PURPOSES ALIGN WITH THOSE OF THE MUSEUM OF

FINE TRIBAL ART.

THE CORPORATION SHALL NOT ENGAGE IN ANY ACTIVITIES THAT WOULD DISQUALIFY IT

FROM TAX-EXEMPT STATUS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE

CODE.
