The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1.	The name of the corporation is The Warren Cousins, Incorporated
2.	The period of its duration is (if perpetual, so state) Perpetual
3.	The specific purpose or purposes for which the corporation is organized are: An educational, genealogical, historical society constituted for the purpose of perpetuating the memory of Richard Warren, Mayflower Pilgrim, and his wife Elizabeth; to collect, preserve, and publish
	information relating to them and their descendants; and to aid research activities relating to them.
4.	Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are: In the event of the dissolution of the Warren Cousins, the net assets of the corporation shall be distributed to the Pilgrim John Howland Society, Incorporated, or to such other organization or organizations which have qualified under section 501(c)(3) of the Internal Revenue Code, as may be directed by the Board of Directors in office at the time of dissolution, and if none, then as may be directed by the Probate Court of Plymouth, Massachusetts. Not withstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.
