Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is AMRITA WATERS

ARTICLE II

The specific purpose or purposes for which the corporation is organized are:

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THIS CORPORATION IS ORGANIZED AND OPERATED EXCLUSIVELY FOR
RELIGIOUS AND
SPIRITUAL PURPOSES UNDER SECTION 508(C)(1)(A) OF THE INTERNAL REVENUE
CODE.

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL OR MEMBER, AND NO PART OF THE ACTIVITIES OF THE CORPORATION SHALL INCLUDE PARTICIPATION IN, OR INTERVENTION IN, ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY A CHURCH, MINISTRY, OR RELIGIOUS ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 508(C)(1)(A).

UPON DISSOLUTION, ASSETS SHALL BE DISTRIBUTED TO ONE OR MORE ORGANIZATIONS THAT ARE RECOGNIZED AS TAX-EXEMPT UNDER SECTION 501(C)(3) OR 508(C)(1)(A), AND THAT ARE ALIGNED WITH THE SPIRITUAL AND RELIGIOUS PURPOSES OF THIS CORPORATION.
