Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Cranston East Little League

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CRANSTON EAST LITTLE LEAGUE (CELL) EXISTS TO PROVIDE A PROGRAM OF ORGANIZED BASEBALL FOR YOUTH BETWEEN THE AGES OF 4 AND 16 UNDER THE LEADERSHIP OF RESPONSIBLE ADULTS IN THE COMMUNITY. THE OBJECTIVE OF THE LEAGUE SHALL BE TO IMPLANT FIRMLY IN THE YOUTH OF THE COMMUNITY THE IDEALS OF GOOD SPORTSMANSHIP, HONESTY, LOYALTY, COURAGE, AND RESPECT FOR AUTHORITY WHILE TEACHING THE FUNDAMENTALS OF BASEBALL.
