ORDERED, ADJUDGED AND DECREED

- 1. All of the Receiver's acts, doings, and disbursements as Temporary and Permanent Receiver are approved, confirmed, and ratified.
- 2. That the Receiver's Recommendation on Allowance of Claims is approved and his Proposed Distribution to Allowed Claimants is authorized.
- 3. That the Receiver's request for approval of fees incurred in the amount of \$832,810.90 and for reimbursement of costs advanced in the amount of \$4,849.43 is approved and the Receiver's voluntary reduction for payment of his fee award from \$832,810.90 to \$594,145.36 is approved and the Receiver is authorized to be paid \$594,145.36 for fees and \$4849.43 for reimbursement of expenses incurred.
- 4. The Receiver is authorized and directed to pay the Allowed Administrative claim of Elsa Shum into the registry of the Probate Court if Probate proceedings for her Estate have been commenced, otherwise, the Receiver is directed to pay the Elsa Shum Allowed Claim into this Court's Registry.
- 5. The Court approves the Receiver's recommendation for approval of the allowance of Allowed Unsecured Claims, as are specifically set forth as to claimant and amount on Schedule D of the Final Report, in the total amount of \$70,865.56 ("Total Allowed Unsecured Claims").
