Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Electrical Inspectors Association

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSES AND OBJECTIVES OF THE THE ASSOCIATION SHALL BE:

(A) THE RHODE ISLAND ELECTRICAL INSPECTOR ASSOCIATION PROMOTES UNIFORM UNDERSTANDING AND APPLICATION OF THE RHODE ISLAND ELECTRICAL CODE TO ENHANCE SAFE INSTALLATION AND USE OF ELECTRICITY.

(B) TO PROMOTE THE WELFARE OF ALL JURISDICTIONS WITHIN ITS TERRITORY.

(C) TO PROMOTE UNIFORM UNDERSTANDING, EDUCATE AND APPLICATION, AND ENFORCEMENT OF RHODE ISLAND ELECTRICAL CODE.

(D) TO PROMOTE ALL MEANS OF INCREASING THE LEVEL OF PROFESSIONALISM AND EFFICIENCY OF LOCAL ELECTRICAL INSPECTORS.

(E) TO CREATE A BETTER PUBLIC UNDERSTANDING AND APPRECIATION OF RHODE ISLAND ELECTRICAL CODE REGULATIONS AND THEIR IMPORTANCE TO PUBLIC HEALTH, SAFETY AND WELFARE.

(F) TO PROMOTE AND IMPROVE THE STANDARD OF THE PROFESSION OF

ELECTRICAL
INSPECTORS.
