# ATTACHMENT TO ARTICLES OF AMENDMENT FOR NORTHEAST BEVERAGE CORP. OF RHODE ISLAND

5. Statement of Designations; Power, Preferences and Rights; and Qualifications, Limitations and Restrictions

Voting and Non-Voting Common Stock shall have the same rights and privileges for all purposes, including participation in dividends or in the distribution of assets upon the voluntary or involuntary liquidation, dissolution or winding up of the Corporation or upon the merger or consolidation of the Corporation except that the holders of Voting Common Stock shall have the sole voting power for the election of directors of the Corporation and for the approval of all corporate actions and other matters with respect to which a vote of shareholders is required or obtained, and holders of Non-Voting Common Stock shall have no right, except insofar as otherwise expressly mandated by then-applicable law, to vote on any such matters.

8.

Article I shall be updated as follows:

The name of the corporation is Northeast Beverage Corp. of Rhode Island. This is a close corporation pursuant to R.I.G.L. §7-1.2-1701 of the General Laws, 1956, as amended.

A new Article VIII is added as follows:

Majority Vote. Action pursuant to R.I.G.L. §7-1.2-707 is hereby authorized. Without limiting the foregoing, except for actions pursuant to R.I.G.L. §7-1.2-1002 or §7-1.2-1102, any action required or permitted to be taken at a meeting of shareholders may be taken without a meeting upon the written consent of less than all the shareholders entitled to vote on the action, if shareholders who consent would be entitled to cast at least the minimum number of votes that would be required to take the action at a meeting at which all shareholders entitled to vote on the action are present and voting in person or by proxy. Prompt notice of any such action must be given to all shareholders who would have been entitled to vote upon the action if the meeting were held.
