CALLED BY THE

PRESIDENT OR A MAJORITY OF DIRECTORS.

SECTION 5. QUORUM AND VOTING:

A QUORUM SHALL CONSIST OF A MAJORITY OF CURRENT DIRECTORS.

DECISIONS SHALL BE

MADE BY MAJORITY VOTE.

SECTION 6. REMOVAL AND VACANCIES:

A DIRECTOR MAY BE REMOVED WITH OR WITHOUT CAUSE BY A TWO-THIRDS

VOTE.

VACANCIES MAY BE FILLED BY THE BOARD.
