The term Protected Person means: each Member; each Member's employees or agents, and each of the Company's Managers, employees, and agents.
- II. The Operating Agreement also includes provisions for the purpose of indemnifying, holding harmless, defending, paying, and reimbursing, to the fullest extent permitted by the Act and all other applicable law, each *Protected Person*.
- III. The Manager or Managers of the Company may authorize that agreements be entered into with each Protected Person for the purpose of indemnifying, holding harmless, defending, paying, and reimbursing each Protected Person to the fullest extent permitted by the Act and all other applicable law.
