

ARTICLES OF ORGANIZATION
EXHIBIT "A"

8. Additional provisions not inconsistent with law set forth in these Articles of Organization:

I. The Operating Agreement of the limited liability company (hereinafter referred to within this Exhibit A as the "Company"), as on file with the Company's resident agent and as may from time to time be amended (hereinafter referred to within this Exhibit A as the "Operating Agreement"), provides that no *Protected Person* is liable to the Company or any other Protected Person for any loss, damage, or claim incurred because of breach of any duty provided for under Section 17 of the Rhode Island Limited Liability Company Act (Title 7, Chapter 16 of the General Laws of Rhode Island, 1956) as the same may be amended from time to time, or for any other action taken or not taken by the Protected Person in good-faith reliance on the provisions of the Operating Agreement except as otherwise may be specifically provided therein or required by Section 18 of the Rhode Island Limited Liability Company Act (Title 7, Chapter 16 of the General Laws of Rhode Island, 1956) as the same may be amended from time to time. The term *Protected Person* means: each Member; each Member's employees or agents, and each of the Company's Managers, employees, and agents.

II. The Operating Agreement also includes provisions for the purpose of indemnifying, holding harmless, defending, paying, and reimbursing, to the fullest extent permitted by the Act and all other applicable law, each *Protected Person*.

III. The Manager or Managers of the Company may authorize that agreements be entered into with each Protected Person for the purpose of indemnifying, holding harmless, defending, paying, and reimbursing each Protected Person to the fullest extent permitted by the Act and all other applicable law.
