Dear Ms. Eastman:

The Office of the Attorney General has received your request to waive or reduce The Women's Guild of Beneficent Congregational Church (United Church of Christ) LLC.'s late fee for a delay in submitting its 2025 annual report. The reason stated for your request is that you submitted the report on February 1, 2025, along with a check for \$20.00 as the renewal payment (check number 1594), but these were not received by the Secretary of State.

Pursuant to R.I. Gen. Laws § 7-1-23, the Attorney General may "compromise" any penalty and permit the payment of a "smaller sum" than what has been assessed. There is, however, no provision for complete waiver of fees.

After reviewing the information that you provided to this Office and having found no consumer complaints or lawsuits against this company, this letter is to inform you that the Attorney General authorizes a reduction from \$25.00 to \$5.00. This is contingent, however, on the entity submitting the 2025 annual reports to the Secretary of State and paying the filing fees.

You must provide a copy of this letter to the Secretary of State in order to reduce penalty fees. If you have any questions, please contact this Office.
