**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Landmark Church, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THIS NONPROFIT CORPORATION IS ORGANIZED AND OPERATED EXCLUSIVELY FOR RELIGIOUS, CHARITABLE, EDUCATIONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. IN FURTHERANCE OF THESE EXEMPT PURPOSES, THE NONPROFIT WILL CONDUCT CHURCH SERVICES AND MINISTER TO THE COMMUNITY TO SPREAD THE GOSPEL OF JESUS CHRIST.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

ADDITIONAL LANGUAGE OR PROVISIONS:

(1) THE BOARD OF DIRECTORS SHALL CONDUCT ALL THE BUSINESS OF THE CORPORATION EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED IN THE BYLAWS. THE NUMBER OF DIRECTORS, THE

QUALIFICATIONS OF DIRECTORS, AND THE MANNER OF THEIR ADMISSION
SHALL BE AS
SET FORTH IN
THE BYLAWS.

(2) (A) NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO
THE BENEFIT
OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, IF ANY, DIRECTORS, OFFICERS, OR
OTHER PRIVATE
PERSONS, EXCEPT
THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY
REASONABLE
COMPENSATION
FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN
FURTHERANCE
OF THE
PURPOSES SET FORTH HEREOF.

(B) NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE
THE
CARRYING ON
OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION,
AND THE
CORPORATION
SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR
DISTRIBUTION OF
STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR
PUBLIC
OFFICE.

(C) NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE
CORPORATION SHALL NOT
CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A
CORPORATION EXEMPT
FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL
REVENUE
CODE, OR THE
CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY A
CORPORATION,
CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C)(2) OF THE
INTERNAL REVENUE
CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

(D) UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE
DISTRIBUTED
FOR ONE OR
MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE
INTERNAL REVENUE
CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE,
OR SHALL

BE
DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL
GOVERNMENT,
FOR A PUBLIC
PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A
COURT OF
COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE
OF THE
CORPORATION IS
THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION
OR
ORGANIZATIONS, AS
SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED
EXCLUSIVELY
FOR SUCH
PURPOSES.
(3) THESE ARTICLES MAY BE AMENDED AT ANY REGULAR MEETING OF THE
BOARD
OF DIRECTORS,
OR AT A SPECIAL MEETING CALLED FOR THAT PURPOSE, BY A TWO-THIRDS (2/3)
MAJORITY.
