Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is The Lord's Disciples

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

THE LORD'S DISCIPLES IS ORGANIZED EXCLUSIVELY FOR CHARITABLE,  
RELIGIOUS,  
EDUCATIONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES,  
THE  
MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT WOULD QUALIFY AS  
EXEMPT  
ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE,  
OR THE  
CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE

THE ORGANIZATION IS GUIDED BY CHRISTIAN PRINCIPLES IN ITS DEDICATION  
TO  
FEEDING THE HUNGRY, SERVING THE LESS FORTUNATE AND SPREADING THE  
TEACHING  
THROUGH SERVICE AND THROUGH TRUE FELLOWSHIP.

THE INTERNAL AFFAIRS OF THE CORPORATION SHALL BE REGULATED BY THE  
BYLAW,  
AND THE BOARD OF DIRECTORS SHALL SUPERVISE THE MANAGEMENT OF THE  
BUSINESS  
AND AFFAIRS OF THE CORPORATION IN ACCORDANCE WITH BY LAWS

A. THIS CORPORATION SHALL NOT DIRECTLY OR INDIRECTLY ENGAGE IN ANY

ACTIVITY:

1. THAT WILL PREVENT THIS CORPORATION FROM QUALIFYING (AND CONTINUING TO QUALIFY) AS A CORPORATION DESCRIBED IN SECTION 501 (C) (3) OF THE CODE AND REGULATIONS THEREUNDER, OR

2. WHICH IS PROHIBITED BY AN ORGANIZATION THAT CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 (C)(2) OF THE CODE AND REGULATIONS THEREUNDER

B. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, DIRECTORS, OFFICERS, OR OTHER PRIVATE'S PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICE RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS AND FURTHERANCE OF THE PURPOSE SET FORTH IN ARTICLE THIRD HEREOF.

C. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

UPON THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO

DISPOSED OF  
SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF THE  
COUNTY IN  
WHICH THE PRINCIPAL OFFICE OF THE ORGANIZATION IS THEN LOCATED,  
EXCLUSIVELY  
FOR SUCH PURPOSES OR TO SUCH ORGANIZATION(S), AS SAID COURT SHALL  
DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH  
PURPOSES.
