**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Hope To The Nations

ARTICLE II

The period of its duration is Perpetual _____

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

THE SPECIFIC PURPOSES OF THE CORPORATION ARE TO PROVIDE HUMANITARIAN AID AND RELIEF SERVICES TO UNDERSERVED POPULATIONS, INCLUDING THE POOR, THE SICK, AND THE NEEDY, BOTH DOMESTICALLY AND INTERNATIONALLY. ACTIVITIES MAY INCLUDE, BUT ARE NOT LIMITED TO: DISTRIBUTION OF FOOD, CLOTHING, MEDICAL SUPPLIES, AND HYGIENE PRODUCTS; SUPPORT FOR EDUCATION AND VOCATIONAL TRAINING PROGRAMS; COORDINATION OF VOLUNTEER OUTREACH; AND COLLABORATION WITH LOCAL AND GLOBAL PARTNERS TO DEVELOP SUSTAINABLE COMMUNITY PROJECTS.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 OR ANY CORRESPONDING FUTURE PROVISION OF THE U.S. INTERNAL REVENUE LAW.

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO, ITS MEMBERS, DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS IN FURTHERANCE OF THE CORPORATION'S PURPOSES.

UPON DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR TO ANOTHER ORGANIZATION ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, OR SIMILAR PURPOSES, AS DETERMINED BY THE BOARD OF DIRECTORS.

THE CORPORATION SHALL BE GOVERNED EXCLUSIVELY BY ITS BOARD OF DIRECTORS, WHO SHALL SERVE INDEFINITE TERMS UNTIL RESIGNATION OR REMOVAL.
