THE OPERATING AGREEMENT OF THE LIMITED LIABILITY COMPANY (HEREINAFTER REFERRED TO WITHIN THIS EXHIBIT A AS THE “COMPANY”), AS ON FILE WITH THE COMPANY’S RESIDENT AGENT AND AS MAY FROM TIME TO TIME BE AMENDED (HEREINAFTER REFERRED TO WITHIN THIS EXHIBIT A AS THE “OPERATING AGREEMENT”), PROVIDES THAT NO PROTECTED PERSON IS LIABLE TO THE COMPANY OR ANY OTHER PROTECTED PERSON FOR ANY LOSS, DAMAGE, OR CLAIM INCURRED BECAUSE OF BREACH OF ANY DUTY PROVIDED FOR UNDER SECTION 17 OF THE RHODE ISLAND LIMITED LIABILITY COMPANY ACT (TITLE 7, CHAPTER 16 OF THE GENERAL LAWS OF RHODE ISLAND, 1956) AS THE SAME MAY BE AMENDED FROM TIME TO TIME (THE “ACT”), OR FOR ANY OTHER ACTION TAKEN OR NOT TAKEN BY THE PROTECTED PERSON IN GOOD-FAITH RELIANCE ON THE PROVISIONS OF THE OPERATING AGREEMENT EXCEPT AS OTHERWISE MAY BE SPECIFICALLY PROVIDED THEREIN OR REQUIRED BY SECTION 18 OF THE ACT. THE TERM PROTECTED PERSON MEANS: EACH MEMBER; EACH MEMBER’S EMPLOYEES OR AGENTS, AND EACH OF THE COMPANY’S MANAGERS, EMPLOYEES, AND AGENTS.
