

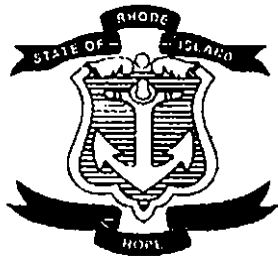

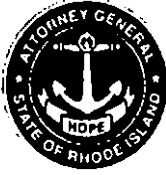

Dear Mr. Melino:

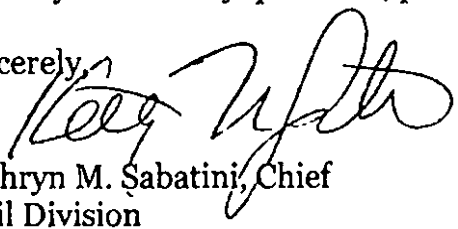
The Office of the Attorney General has received your request to waive or reduce ToolLab, Inc.'s late fee for a delay in submitting its 2014-2025 annual reports. The reason stated for your request is that the fees in question reflect a period of time wherein the business was being operated by previous owners. You have since regained ownership and are reestablishing operations.

Pursuant to R.I. Gen. Laws § 7-1-23, the Attorney General may "compromise" any penalty and permit the payment of a "smaller sum" than what has been assessed. There is, however, no provision for complete waiver of fees.

After reviewing the information that you provided to this Office and having found no consumer complaints or lawsuits against this company, this letter is to inform you that the Attorney General authorizes a reduction from \$550.00 to \$55.00. This is contingent, however, on the entity submitting the 2014-2025 annual reports to the Secretary of State and paying the filing fees.

You must provide a copy of this letter to the Secretary of State in order to reduce penalty fees. If you have any questions, please contact this Office.
