R.I.G.L. 7-6-94 states that any non-profit corporation failing or refusing to file its annual report for any year within thirty (30) days after the time prescribed by law is subject to a penalty fee of \$25.00. Due to the late filing, the fee for the 2025 annual report is now \$45.00.
