This letter is to certify that records currently in the possession of the Division of Banks indicate that First East Savings Bank, Lynn, Massachusetts merged with Salem Savings Bank, Salem, Massachusetts under the charter of Salem Savings Bank and the name of Eastern Savings Bank on April 30, 1981. Effective October 19, 1989, Eastern Savings Bank, Lynn, Massachusetts reorganized into a mutual holding company, Eastern Bank Corporation, with a subsidiary banking institution, Eastern Bank, in stock form. Effective July 31, 2004, Eastern Bank was converted, by operation of law, to a state-chartered trust company. Eastern Bank Corporation, which was the mutual holding company for Eastern Bank, converted to a stock holding company, Eastern Bankshares, Inc., effective October 14, 2020. Eastern Bank, Boston, Massachusetts continues to operate as a state-chartered trust company under the provisions of Massachusetts General Laws chapter 172 and other related statutes, subject to supervision and examination by the Commissioner of Banks.
