SINGLE-MEMBER STRUCTURE.

THIS IS A SINGLE-MEMBER LIMITED LIABILITY COMPANY. ALL AUTHORITY TO MANAGE AND OPERATE THE COMPANY IS VESTED SOLELY IN THE MEMBER.

LIMITATION OF LIABILITY.

TO THE FULLEST EXTENT ALLOWED BY RHODE ISLAND LAW, THE MEMBER SHALL NOT BE PERSONALLY LIABLE FOR THE DEBTS, OBLIGATIONS, OR LIABILITIES OF THE COMPANY SOLELY BY REASON OF BEING THE MEMBER.

INDEMNIFICATION.

THE COMPANY SHALL INDEMNIFY AND HOLD HARMLESS THE MEMBER FROM ANY CLAIMS, LOSSES, OR LIABILITIES INCURRED IN CONNECTION WITH THE BUSINESS, EXCEPT THOSE ARISING FROM FRAUD OR INTENTIONAL MISCONDUCT.

AUTHORITY OF MEMBER.

THE MEMBER HAS FULL AUTHORITY TO BIND THE COMPANY, ENTER INTO CONTRACTS, HIRE SUBCONTRACTORS AND EMPLOYEES, PURCHASE SUPPLIES AND EQUIPMENT, AND MAKE ALL DECISIONS RELATING TO THE PAINTING BUSINESS.

OPERATING AGREEMENT.
