1. That the First and Final Report of Diane Finkle, Permanent Receiver herein, and all acts, doings, and disbursements of said Receiver are hereby approved, confirmed and ratified;
2. That the Recommendation on Allowance of General Unsecured Claims filed herein by said Receiver is hereby approved;
3. That said Receiver is hereby directed to pay \$ 62,639.79 to herself on account of her additional services rendered and expenses incurred herein as Permanent Receiver herein, to pay \$ 10,873.87 to Davis, Kilmarx, Swan & Bowling, LLP for its services rendered herein, and to distribute the remaining funds on hand pro rata to general unsecured creditors whose claims have been allowed as set forth in the Receiver's Recommendation on Allowance of General Unsecured Claims, an estimated dividend of 8%;

4. That said Receiver is hereby authorized to abandon any outstanding assets of Defendant and any of its books and records and to destroy such books and records in the Receiver's possession or control;


5. That said Receiver is hereby discharged and the Receivership Bond ordered cancelled;
