ARTICLES OF ASSOCIATION

The undersigned, acting as incorporator(s) of an association under Chapter 7-8 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Association for such association:

1. The name of the consumers' cooperative association is Narragansett Bay Seafood Cooperative

(The name must contain the word "cooperative".)

2. The period of its duration is (if perpetual, so state) Perpetual

3. The purpose or purposes for which the association is organized are:
to engage in any lawfull act or activity for which cooperatives may be formed under the general laws of Rhode Island and engaqing in any and all activities nessessary or incidental to the foregoing.

4. The association is organized with shares or without shares *(check one box only)*

5. The aggregate number of shares which the association shall have the authority to issue is:


