FIRST: Article 1 of the Articles of Incorporation shall be amended to read as follows: The name of the corporation is American Flat Glass Distributors, Inc.

SECOND: A new Article 9 shall be added to the Articles of Incorporation and shall read as follows: The Board of Directors, by resolution adopted by a majority of the full Board of Directors, may designate from among its members an Executive Committee, and one or more other committees each consisting of two or more directors and each of which, to the extent provided in such resolution, shall have and may exercise all the authority of the Board of Directors. The designation of an Executive Committee or other committee and the delegation thereto of authority shall not operate to relieve the Board of Directors, or any member thereof, of any responsibility imposed by law.

THIRD: The above amendments to the Articles of Incorporation were adopted by unanimous written consent of the sole shareholder of the corporation on May 27, 1986, in the manner prescribed by the Georgia Business Corporation Code.




