We, the undersigned, do hereby give notice that we have signed, sworn to and on this *30th* day of October, 1943, have filed and recorded in the Office of the Secretary of State of the State of Rhode Island a certificate of limited partnership certifying as follows:

1. That the name of the limited partnership is "Cherry Brook Worsted Mills".
2. That the character of its business is the conducting of the business of manufacturing woolen and worsted tops and yarns.
3. That the location of the principal place of business of the said limited partnership shall be Mason Street, in the City of Woonsocket, in the County of Providence and State of Rhode Island.
4. That the name and place of residence of each partner and the designation of which is general partner and which are limited partners are as follows:

5. That the partnership shall commence on the First day of November, 1943, and shall continue for five (5) years or until terminated by a notice in writing signed by the general partner and sent by registered mail addressed to each limited partner and to the partnership at their respective addresses as the same appear on the books of the partnership, of an intention to terminate the partnership at the time stated in said notice, which shall be not less than thirty (30) days after the mailing of said notice.

6. That the amounts of cash contributed

by the limited partners are as follows:

7. That the limited partners shall  
make no additional contributions at any time.

8. That the contributions of the  
limited partners shall be returned upon termination or  
dissolution of the partnership.

9. That the share of profits or other  
compensation by way of income that the limited partners  
shall receive by reason of their contributions shall be  
the following percentage of the net profits of the limited  
partnership:

A. Jarret, Jr., twenty per cent (20%).

Hugo A. Jarret, as Trustee for  
Suzanne R. Jarret, twenty per cent (20%).

Hugo A. Jarret, as trustee for Sally

10. That the limited partners shall have no right to substitute assignees as contributors in their place.

11. That the general partner may admit additional limited partners at any time.

12. That no limited partner shall have any priority over any other limited partner, but limited partners shall have priority in the return of their contributions over the general partner.

13. That no right is given to the remaining limited partners to continue the business of the partnership on the death, retirement or insanity of the general partner.

14. That no limited partner shall have a right to demand and receive property other than cash in return for his contribution.
