The Receiver has been appointed as a neutral, impartial Receiver, for the purpose of stabilizing the financial affairs of the companies, and, subject to Court approval, after notice to all creditors, marketing and selling the business and assets for the highest value, in order to maximize recovery for creditors.

Preliminarily, it appears that the companies have secured creditor debt of approximately \$342,000.00. The amount of the unsecured debt is currently unknown.

In connection with the Receivership, as set forth in Paragraph 6 of the enclosed Order:

Appointing Temporary Receiver, all creditors are enjoined and stayed from taking any action to enforce their claims against the companies and their assets.

No claims will be approved and no distribution to creditors will take place without notice to all creditors and other parties in interest who file a <u>Proof of Claim</u> with the Receiver, after a Hearing thereon before the Rhode Island Superior Court.

In order that your interests be protected and that you make sure that you receive notice of all appropriate court filings in connection with this case, I am taking the liberty of enclosing a <u>Proof of Claim</u> form which I suggest that you complete, execute before a Notary Public, and return to me at the earliest possible date.
