### **FoodService**

The foodservice equipment segment manufacturers commercial food service equipment including refrigerated cabinets, cases, display units and modular structures, coolers and freezers, refrigerated walk-in coolers, prefabricated refrigerated and low temperature warehouse structures, freezers, refrigeration systems, display, storage and dispensing cabinets and cases, refrigeration and environmental storage equipment, milk storage and dispensing equipment; commercial cook and hold units, deck ovens, countertop ovens, pizza equipment, conveyor ovens, convection ovens, combination convection and steam ovens, cook and hold ovens, charbroilers, griddles, toasters, countertop warming units, countertop merchandising units, overhead warmers, holding drawers, plate dispensers, rotisseries, pressure fryers, baking equipment, bakery and deli display cases, custom fabrication and rotary vane pumps.

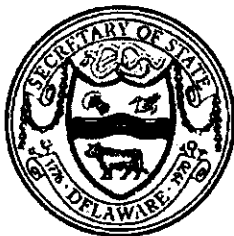
