ARTICLE I

in these Articles of Incorporation:

ANY ACTION—EXCEPTING ACTIONS PURSUANT TO SECTIONS 7-1.2-1002 OR 7-1.2-1102 OF THE RHODE ISLAND GENERAL LAWS—REQUIRED OR PERMITTED TO BE TAKEN AT A MEETING OF SHAREHOLDERS MAY BE TAKEN WITHOUT A MEETING, WITHOUT PRIOR NOTICE, AND WITHOUT A VOTE IF CONSENTED TO IN WRITING BY THE HOLDERS OF OUTSTANDING SHARES HAVING AT LEAST THE MINIMUM NUMBER OF VOTES NECESSARY TO AUTHORIZE OR RATIFY SUCH ACTION IF TAKEN AT A MEETING AT WHICH ALL SHARES ENTITLED TO VOTE WERE PRESENT AND VOTED. PROMPT NOTICE OF SUCH ACTIONS SHALL BE GIVEN TO ALL SHAREHOLDERS WHO WOULD HAVE BEEN ENTITLED TO VOTE UPON SUCH ACTION IF A MEETING OF SHAREHOLDERS WERE HELD.

THE CORPORATION MAY BE DISSOLVED AT ANY TIME UPON AN AFFIRMATIVE VOTE OF THE HOLDERS OF 51 PERCENT OR MORE OF THE SHARES OF THE CORPORATION.

THE SALE, TRANSFER, OR OTHER DISPOSITION OF SHARES IN THE CORPORATION IS RESTRICTED IN ACCORDANCE WITH THE PROVISIONS OF THE BY-LAWS OF THE CORPORATION.
