**ORDERED, ADJUDGED AND DECREED**


1. The Permanent Receiver's Final Report is hereby *APPROVED*;
2. All of the acts, doings and disbursements of the Permanent Receiver as of the filing date of the Final Report are hereby approved, confirmed and ratified;
3. The Permanent Receiver is hereby authorized and directed to undertake the proposed disbursements to general unsecured creditors as provided in *Exhibit A* of the Final Report;
4. The Receiver's legal fees and expenses in the amount of \$11,475.57, are hereby approved and further, the Receiver is hereby authorized and directed to pay the same from the Estate's account;
5. The Receiver is hereby authorized to reserve the amount of \$4,000.00 for any wind down expenses of the Receivership Estate;


6. The Receiver is hereby authorized to compromise the claim of Mr. Ronald Lang for a compromise payment of \$1,843.93, which said payment shall be made from the above-listed reserve in full satisfaction of said claim;
7. PRS in Receivership Corp. shall be dissolved forthwith;
8. The Receiver's bond shall be cancelled forthwith;
9. The Clerk's Office shall deliver a copy of the instant Order to the Rhode Island Secretary of State's Office; and
10. The Receiver is hereby discharged.
