**FINAL ORDER AND JUDGMENT**

The above entitled action, having come before this Honorable Court, Associate Justice Michael A. Silverstein presiding, on October 2, 2015, upon the Final Report and Request for Approval of Claims Recommendations regarding TEL Realty, LLC, by the Receiver, Vincent A. Indeglia, in and only in his capacity as the duly appointed Permanent Receiver and not individually (hereinafter referred to as the "Receiver"), and, after considering the papers and pleadings in this matter, as well as any and all representations of counsel in open Court, no Objection having been filed, and the Court being satisfied that notice of said hearing has been given to all interested parties, as well as to all creditors who have filed a Proof of Claim in this matter, it is hereby:

**ORDERED, ADJUDGED AND DECREED:**

1. That the Receiver's Final Report and Request for Approval of Claims Recommendations regarding TEL Realty, LLC is hereby **APPROVED**;
2. That all acts, deeds and doings of the Receiver, from the date of the appointment of Temporary Receiver up through and including this order, during the entire course and scope of this Receivership proceeding, are hereby **APPROVED**, confirmed and ratified by this Court in all respects and further that the Receiver has acted in the best interest of the Receivership Estate and all creditors, stake holders and interested parties;

3. That all Claims Recommendations and disbursements by the Receiver contained in the Final Report are **APPROVED**, with the Receiver having paid all claimants to their satisfaction as identified in the Claims Report and Recommendation attached to the Receiver's Final Report;
4. That the Receiver's Request for Fees and Expenses is granted as prayed for in the aggregate amount of \$22,220.36, with such amount being the remaining cash on hand in the Receivership Estate, and the Receiver is authorized to pay said fees and expenses from the funds on hand within the Receivership Estate forthwith, with the awareness that such funds on hand shall not amount to a full payment and disbursement for all fees and expenses incurred by the Receiver;
5. That the Receiver is hereby permitted to destroy all of the records maintained in this matter after 180 days from the entry of this Final Order and Judgment dismissing this Receivership;
6. That the Clerk of Court shall file this Order with the Rhode Island Secretary of State and order the judicial Dissolution of TEL Realty, LLC;
7. That the Receiver may cancel the Receivership Bond in the instant matter; and,
8. That the Receiver is hereby discharged from his obligations under the Temporary and Permanent Receivership Orders entered in this proceeding.
