## **INSTRUCTIONS FOR FILING**

- 1. Prior to submitting the Statement of Change of Registered Agent/Specified form for filing, it is recommended that you call the Division of Business Services at (401) 222-3040 to verify that the information required in items 2, 4 and 6 of the form currently appears in the records of the Secretary of State. If the information is inconsistent with the records of this office the statement will be returned.
- The limited partnership must continuously maintain in this state an office, which may, but need not be, a place of its business in this state, at which shall be kept the records required by Section 7-13-5 of the General Laws, 1956, as amended.
- 3. It is required by law to provide a street address for the registered office in order to provide the public with notice of a physical location at which process, notice or demand required or permitted by law may be served on the registered agent. A statement submitted with a post office box address only will not be accepted for filing.
- 4. The Change of Specified Office and/or Registered Agent, as the case may be, shall become effective upon the date of filing with the Secretary of State. A general partner of the limited partnership must sign the form.
- 5. The filing fee for the Statement of Change of Specified Office or Registered Agent is \$20.00 and payment shall be made payable to "Secretary of State".
