

APPLICATION OF COMMISSIONERS OF THE TOWN OF NORTH
PROVIDENCE HOUSING AUTHORITY FOR A CORPORATE CHARTER
PURSUANT TO SECTION 45-25-7, GENERAL LAWS OF
RHODE ISLAND, 1956

Now come the undersigned, who, being duly sworn,
make affidavit as follows:

(1) That on the 4th day of June, A.D. 1962, following notice duly given pursuant to section 45-26-2 and 45-25-4, General Laws of Rhode Island, 1956, a public hearing was held in the Council Chamber, Town Hall, North Providence, Rhode Island, before the Honorable Council of the Town of North Providence, to determine whether there was a need for a town housing authority to function in the Town of North Providence; that after said public hearing, on the same date, the said Town Council by Resolution duly passed June 4, 1962 and approved by Town Council on the same date, determined that (a) unsanitary or unsafe inhabited dwelling accommodations existed in the town, and (b) that there was a lack of safe or sanitary dwelling accommodations in the town available for the inhabitants thereof; and consequently that there was a need for the town housing authority to function in the Town of North Providence;

That pursuant to section 45-25-7, General Laws of Rhode Island, 1956, the Town Council of the Town of North Providence, duly appointed the undersigned Commissioners of the Town of North Providence Housing Authority.
