Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is FULFILLED COVENANT BIBLE CHURCH, INC.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO ESTABLISH A CHURCH IN EAST PROVIDENCE, RHODE ISLAND

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

1. THIS NON-PROFIT ORGANIZATION IS ORGANIZED AND OPERATED EXCLUSIVELY AS A CHURCH; NO NET EARNINGS MAY INURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL OR SHAREHOLDER; NO SUBSTANTIAL PART OF ITS ACTIVITY MAY BE ATTEMPTING TO INFLUENCE LEGISLATION; IT SHALL NOT INTERVENE IN POLITICAL CAMPAIGNS; AND THIS ORGANIZATION'S PURPOSES AND ACTIVITIES SHALL NOT BE ILLEGAL OR VIOLATE FUNDAMENTAL PUBLIC POLICIES.

2.NO PART OF THE NET INCOME OR PROFIT OF THIS NON-PROFIT CORPORATION WILL BE DISTRIBUTABLE TO ITS MEMBERS, DIRECTORS, OR OFFICERS.

3. NO PERSON OR ENTITY SERVING AS A VOLUNTEER, DIRECTOR, OFFICER, TRUSTEE, ELDER, PASTOR OR SERVER FOR THIS ORGANIZATION SHALL BE HELD LIABLE TO ANY PERSON BASED SOLELY ON HIS/HER CONDUCT IN THE EXECUTION OF THE OFFICE OR DUTY UNLESS THE CONDUCT OF SAID PERSON OR ENTITY TOWARD THE PERSON OR ENTITY ASSERTING LIABILITY CONSTITUTED MALICIOUS, WILLFUL, OR WANTON MISCONDUCT.

4. THE INITIAL BOARD OF DIRECTORS SHALL BE THOSE WHOM WHICH ARE NAMED IN THIS ARTICLES OF INCORPORATION BY THE INCORPORATOR. THEREAFTER, THE BOARD, UPON ITS FIRST MEETING, SHALL EITHER RATIFY AND CONSENT TO THE INCORPORATOR'S NOMINATIONS, OR MAKE CHANGES PURSUANT TO ANY BYLAWS THAT ARE HEREAFTER DRAFTED.
