(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The K.E.V. Project

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

PROVIDES MENTORING AND LEADERSHIP PROGRAMS FOR MIDDLE AND HIGH SCHOOL MALE YOUTH IN THE GREATER EAST PROVIDENCE AREA. THIS PROGRAM WILL PARTNER WITH THE EAST PROVIDENCE SCHOOL DISTRICT AND THE JUVENILE COURT SYSTEM. THE K.E.V. PROJECT'S GOAL IS TO CHAMPION LEADERSHIP AND IMPRESS UPON YOUTH MALES, THROUGH PERSONAL RELATIONSHIPS, THE IMPORTANCE OF STRONG INTERPERSONAL SKILLS, INDIVIDUAL/SOCIAL RESPONSIBILITY AND COMMITMENT TO LIFE GOALS. THROUGH THESE MENTOR/MENTEE RELATIONSHIPS THE PROGRAM CAN GIVE THE YOUNG MEN THE NEEDED PRIDE AND COMMITMENT TO ACHIEVE GOALS IN HIGHER EDUCATION, PROFESSIONAL CAREERS, AND ADULTHOOD.
