Plan of Liquidation and Dissolution

This Plan of Complete Liquidation and Distribution (the "Plan") is for the purpose of effecting the complete liquidation and dissolution of Partnership for Families, Inc. (the "Corporation") pursuant to the following steps:

1. The Corporation will cease the active conduct of its business and wind up its affairs; will pay and discharge all of its debts, obligations and liabilities or make adequate provision therefor; and distribute all of its assets in such manner as the Corporation shall determine.

2. After the liabilities of the Corporation have been discharged or adequate provision has been made therefor and all of the Corporation's property has been distributed as recited above, David Caprio, as President of the Corporation and Joanne McGunagle as Secretary of the Corporation (the "Authorized Officers"), will execute and file with the Rhode Island Secretary of State such documents as may be required to effect the Corporation's dissolution.

3. The Authorized Officers of the Corporation, each acting singly and in such officer's sole discretion, on behalf of the Corporation, are hereby authorized and directed to execute and deliver any and all documents, certificates and instruments, to give and deliver all such notices, and to do or cause to be done all such acts and things, as may be necessary or advisable to implement this Plan.
