"VOTED: That the corporation increase the amount of its capital stock from \$400,000. to \$750,000. and that the president and secretary be authorized and directed to pay into the treasury of the State of Rhode Island, for the use of the State, a tax upon such increase of \$350,000. as required by the provisions of its charter, and that they procure and file in the office of the Secretary of State a certificate of the General Treasurer of the State of the fact of payment of such tax, together with a copy of this vote duly certified by the Secretary and under the seal of the corporation.

"VOTED: That the corporation issue and dispose of \$350,000. of its capital stock and that the same be offered to the present stockholders at \$200. per share, thus adding the sum of \$350,000. to the capital account and \$350,000. to surplus account, and that the appropriate officers of the corporation execute and deliver certificates of such shares to subscribers therefor upon receipt of the full price of \$200. per share.

"VOTED: That payments in full for said new capital stock be made on or before January 15, 1927, or, at the option of the subscribers, in five quarterly installments, the first of said installments to be payable January 15, 1927; that all stock paid for in full on or before January 15, 1927, shall immediately be entitled to dividends, and that all installment payments shall bear interest at the rate of five per centum per annum from the date of each payment until January 15, 1928. Provided, that all subscriptions shall be paid in full on or before January 15, 1928, and that all installment payments for or on account of said capital stock shall be in multiples of \$100."
