Now come the undersigned, who, being duly sworn make affidavit as follows:

(1) That on the 28th day of September, A.D. 1962, pursuant to section 45-26-2, General Laws of Rhode Island, 1956, the Honorable Council of the Town of Burrillville did determine that there was a need for a Town Housing Authority to function in the Town of Burrillville; on September 28, 1962, the said Town of Burrillville on its own motion by resolution duly passed on the 28th day of September, 1962 and approved by The Town of Burrillville Town Council on the same date, determined that (a) unsanitary or unsafe inhabited dwelling accommodations existed in the Town of Burrillville, and (b) that there was a lack of safe or sanitary dwelling accommodations in the Town of Burrillville available for the inhabitants thereof; and consequently that there was a need for the Town of Burrillville housing authority to function in the Town of Burrillville;

That pursuant to Section 45-26-5, General Laws of Rhode Island, 1956, the Honorable Town Council of the Town of Burrillville duly appointed the undersigned Commissioners of the Town Housing Authority of the Town of Burrillville.

(2) That the following are the names and residences of the undersigned Commissioners appointed by the Town Council of the Town of Burrillville.
