

APPLICATION OF COMMISSIONERS OF THE TOWN OF CUMBERLAND HOUSING AUTHORITY FOR A CORPORATE CHARTER PURSUANT TO SECTION 45-26-5 and SECTION 45-25-7, GENERAL LAWS OF RHODE ISLAND, 1956.

Now come the undersigned, who being duly sworn, make affidavit as follows:

(1) That on the 23rd day of May, A. D. 1962, following notice duly given pursuant to Section 45-26-2 and Section 45-25-4, General Laws of Rhode Island, 1956, a public hearing was held in the Bernard F. Norton School, Cumberland, Rhode Island, before the Honorable Council of the Town of Cumberland, to determine whether there was a need for a town housing authority to function in the Town of Cumberland; that after said public hearing, on June 14, 1962 the said Town Council by Resolution duly passed July 14, 1962 and approved by the Town Council, on the same date, determined that (a) unsanitary or unsafe inhabited dwelling accommodations existed in the town, and (b) that there was a lack of safe or sanitary dwelling accommodations in the town available for the inhabitants thereof; and consequently that there was a need for the town housing authority to function in the Town of Cumberland;

That pursuant to section 45-26-4 and Section 45-25-7, General Laws of Rhode Island, 1956, the Honorable Town Council of the Town of Cumberland, duly appointed the undersigned Commissioners of the Town Housing Authority of the Town of Cumberland.
