CHAPTER 26, SECTION 5, GENERAL LAWS OF RHODE ISLAND,

*Now comes the undersigned who being duly sworn make affidavit
as follows:*

*1. That on the 18th day of February, 1963 pursuant to Title 45,
Chapter 26, Section 2, of the General Laws of Rhode Island, 1956, in
accordance with authority vested in the Town Council of the Town of
Middletown at a regular meeting held in the Council Chamber of the
Town Council on that date on its own motion gave its consideration
to the need for a Town Housing Authority to function in the Town of
Middletown, that on that same date, the said Town Council, by resolu-
tion duly passed, determined that (a) unsanitary or unsafe inhabited
dwelling accomodations existed in the Town of Middletown and (b) that
there was a lack of safe or sanitary dwelling accomodations in the
Town of Middletown available for the inhabitants thereof, and, conse-
quently, that there was a need for the Town Housing Authority to
function in the Town of Middletown, that pursuant to Title 45,
Chapter 26, Section 4, the Honorable Town Council of the Town of
Middletown duly appointed the undersigned Commissioners of the Town
Housing Authority of the Town of Middletown.*
