desiring to form a limited partnership under and by virtue of the powers conferred by Chapter 7-13 of the General Laws of Rhode Island, do solemnly swear that:

FIRST. The name of the partnership shall be HEVENOR INVESTMENT GROUP

SECOND. The character of the business conducted by the partnership shall be To purchase, own, hold, develop, operate, manage and encumber real estate of all kinds and to do all things incident thereto including mortgaging, selling, leasing and subleasing or otherwise disposing of real estate.

THIRD. The principal place of business of the partnership shall be located at 1514 Smith Street, North Providence, Rhode Island (No. Street, City or Town, State.)

FIFTH. The term of existence of the partnership shall be from the date of filing this certificate until December 31, 1993, however, the partnership shall be sooner terminated upon the happening of the following events:

A. Thirty (30) days after any final disposition by the partnership of its entire interest in the real estate.

B. The death, adjudication in bankruptcy, insanity or incompetency, retirement, resignation of the General Partner, unless, within a period of six (6) months from the date of such event, a successor General Partner is elected by vote of the Limited Partners holding more than fifty per cent (50%) of the then outstanding units, which successor elects to continue the business of the partnership.

C. The decision of the General Partner to dissolve the partnership.

ELEVENTH. The partners shall have the right to admit additional limited partners.

TWELFTH. Not Applicable, a limited partner, shall have the right to priority over the other limited partners as to contributions or as to compensation by way of income, and the nature of such priority shall be

THIRTEENTH. Upon the death, retirement or insanity of a general partner, the remaining general partner or partners shall have the right to continue the business, in accordance with the limited partnership agreement.

FOURTEENTH. Any limited partner shall not have the right to demand and receive property other than cash in return for his contribution.
