THIS PLAN OF COMPLETE LIQUIDATION, DISSOLUTION AND DISTRIBUTION (THE "PLAN") IS FOR THE PURPOSE OF EFFECTING THE COMPLETE DISSOLUTION OF SOUTH QUAY

MARINE TERMINAL, INC., A RHODE ISLAND NONPROFIT CORPORATION (THE

"CORPORATION"), IN ACCORDANCE WITH THE RHODE ISLAND NONPROFIT CORPORATION ACT

(THE "ACT") AND INTERNAL REVENUE CODE OF 1986, AS AMENDED (THE "CODE"). THIS

<u>PLAN WAS APPROVED BY UNANIMOUS WRITTEN CONSENT OF THE BOARD OF DIRECTORS</u>

EFFECTIVE AS OF DECEMBER 19, 2023. THE SPECIFIC STEPS OF DISSOLUTION ARE AS

FOLLOWS:

1. THE CORPORATION WILL IMMEDIATELY CEASE THE ACTIVE CONDUCT OF ITS BUSINESS, EXCEPT INSOFAR AS MAY BE NECESSARY FOR THE WINDING UP THEREOF, AND

PROCEED TO WIND UP ITS AFFAIRS AND, WITHIN THE MEANING OF CODE SECTION 331,

LIQUIDATE AND DISTRIBUTE ALL OF ITS ASSETS.

2. THE OFFICERS OF THE CORPORATION ("AUTHORIZED SIGNATORIES"), SHALL PROCEED WITH THE VOLUNTARY DISSOLUTION OF THE CORPORATION UNDER THE LAWS OF THE STATE OF RHODE ISLAND.

3. AFTER ADOPTION OF THIS PLAN, COUNSEL AND/OR ACCOUNTANTS FOR THE CORPORATION SHALL PREPARE AND ASSIST IN FILING OF ANY REQUIRED STATE OR FEDERAL

TAX RETURNS TOGETHER WITH A COPY OF THE RESOLUTIONS ADOPTING THE PLAN.

4. IT IS INTENDED THAT THIS PLAN SHALL BE A PLAN OF COMPLETE
LIQUIDATION AND DISSOLUTION. THIS PLAN SHALL BE DEEMED TO AUTHORIZE
SUCH

ACTION AS, IN THE OPINION OF COUNSEL OR ACCOUNTANTS FOR THE CORPORATION, MAY BE

NECESSARY TO CONFORM WITH THE PROVISIONS OF APPLICABLE STATE AND FEDERAL TAX

LAW.

5. THE AUTHORIZED SIGNATORIES, EACH ACTING SINGLY, ARE EACH HEREBY AUTHORIZED, EMPOWERED AND DIRECTED TO SIGN, SEAL, EXECUTE, ACKNOWLEDGE AND

<u>DELIVER ANY AND ALL DOCUMENTS AND INSTRUMENTS INCLUDING FEDERAL AND STATE TAX</u>

RETURNS, INFORMATION REQUIRED TO BE FILED BY REASON OF THE COMPLETE LIQUIDATION

AND DISSOLUTION OF THE CORPORATION, AND ALL DOCUMENTS AND INSTRUMENTS WHICH

EACH ACTING SINGLY, DEEMS NECESSARY OR ADVISABLE TO CARRY OUT THE PURPOSES AND

INTENTIONS OF THIS PLAN.
