**COLLATERAL**

- (a) All Accounts and General Intangibles now existing or arising in the future, whether in the ordinary course of the Debtor's business, in respect of the sale of Inventory, or otherwise (including without limitation, (i) all monies due and to become due under any Contract or Account, (ii) any damages arising out of or for breach or default in respect of any such Contract or Account, (iii) all other amounts from time to time paid or payable under or in connection with any such Contract or Account and (iv) the right of the Debtor to terminate any Contract to perform and to exercise all remedies thereunder);
- (b) All Inventory;
- (c) All Equipment and Fixtures
- (d) All Investment Property, Deposit Accounts, Chattel Paper and Commercial Tort Claims;
- (e) All ledger sheets, files, records, documents and instruments (including without limitation, computer programs, tapes and related data processing software) evidencing an interest in or relating to the foregoing Collateral; and
- (f) All instruments, Documents, securities, cash and property, owned by the Debtor or in which Debtor has an interest, which now or hereafter at any time are in the possession and control of the Secured Party or in transit by mail or carrier to or from the Secured Party, without regard to whether the Secured Party received the same in pledge, for safekeeping, as agent for collection or transmission or otherwise or whether the Secured Party had conditionally released the same; and
