THENCE: S.  $66^{\circ} 58' 56''$  W. seventy eight and fifty six one hundredths (78.56) feet, the last line bounding on remaining land of Lot 660, owned by Arkland, LLC;

THENCE: N.  $23^{\circ} 55' 32''$  W. one hundred twenty four and eighty two one hundredths (124.82) feet, to the point and place of beginning, the last line bounding in part by land now or formerly of Sandra Souza and in part by land now or formerly of Peter Martinez.
