6 **BORROWERS:** Timothy Behan of Seekonk, Massachusetts, Thomas

8 Massachusetts, Mark Greenleaf of Foster, Rhode Island, and Kelly Rana of Exeter,
9 Rhode Island individually and jointly and severally.

10 **PRINCIPAL:** One Million, Five Hundred Thousand Dollars and 00/100
11 (\$1,500,000.00)

13 **COLLATERAL:** All stocks and shares in and all assets now and
14 hereinafter acquired by Commonwealth Engineers and Consultants, Inc., a
15 Massachusetts corporation, and Commonwealth Engineers and Consultants, Inc., a
16 Rhode Island corporation, and Wakefield Printing, Inc.

18 **MATURITY DATE:** December 31, 2026 Ten Years

20 **INTEREST RATE:** Interest will be charged on the unpaid principal balance
21 outstanding and will be due and payable monthly in arrears until the full amount of
22 principal has been paid. Borrowers agree to pay interest at the Annual Interest rate
23 of One and ninety five hundredths Percent (1.95 %) per annum.

25 **PAYMENT SCHEDULE:** Five hundred twenty (520) equal weekly
26 installments of Three Thousand One Hundred Seventy Five Dollars and nineteen
27 cents (\$3,175.19) payable commencing on February 24, 2017. All payments are
28 due and payable on Friday of each week and will be applied first to interest due,
29 then to principal.

31 **PROMISE TO PAY:** FOR VALUE RECEIVED, the Borrowers promise to pay
32 to the order of Kambiz Karbassi, P.E. or his successor in interest, heirs or
33 assigns (herein "Holder") at the address of 425 Benefit Street, Providence, RI
34 02903 (or to such other person(s) or at such other place(s) as the Holder of this
35 Note may from time-to-time designate in writing) the Principal, or so much
36 thereof as may have been advanced, with interest until full payment at the Interest
37 Rate (except as otherwise stated in this Note) computed on the outstanding
38 Principal on the basis of a 365 day year for actual days elapsed and payable in
39 arrears. The Borrowers promise to make payments as set forth in the Payment
40 Schedule until the Maturity Date, and on the Maturity Date to pay all
41 outstanding Principal, all accrued interest and any other amount(s) due under this
42 Note. All payments will be applied first to interest then to other charges accrued
43 to the payment due date, and any balance to Principal.

RIGHT OF PREPAYMENT: This Note may be prepaid in full or in part during the term of this Note.

RESPONSIBILITY OF PERSONS: This note shall be paid from the cash flow of the companies. Should the companies cease to exist due to lawsuits or cash flow or bankruptcy or receivership, the holder shall hold the buyers harmless in satisfying the remaining payments under this note.

WAIVER; CHANGES: No delay or omission by the Holder in exercising any right under this Note or under any Loan Document shall operate as a waiver of such right, or of any other right of the Holder, nor shall any delay, omission or waiver on any one occasion be deemed to be a bar to or waiver of the same or of any other right on any future occasion. This Note may be changed only by the agreement of all parties, in writing.

ACCOUNTANTS AND ATTORNEYS: Until this promissory notes are paid in full, Tulis, Miller & Company, LLP will serve as the accountants for Commonwealth Engineers & Consultants, Inc., a Rhode Island corporation, Wakefield Printing, Inc., a Rhode Island corporation, and Commonwealth Engineers & Consultants, Inc., a Massachusetts corporation. Similarly, until the promissory notes are paid in full, Quinlan & Durant will serve as the attorneys for Commonwealth Engineers & Consultants, Inc., a Rhode Island corporation, Wakefield Printing, Inc. a Rhode Island corporation, and Commonwealth Engineers & Consultants, Inc., a Massachusetts corporation.

In the event that either Jerry Tulis, C.P.A. or Patrick J. Quinlan, Esq. commit an error that has serious financial liability implications to the companies, the buyers shall have the right to terminate the services of Jerry Tulis, C.P.A. or Patrick J. Quinlan, Esq. and they shall be permitted to obtain professional services to replace those offered by Jerry Tulis, C.P.A. or Patrick J. Quinlan, Esq. However, until the notes are paid in full, any selection of alternative accounting or legal services provider shall be submitted to the Voting Stock Trustee for ratification.

INSURANCE: Each of the Borrowers shall obtain and maintain term life insurance on each life until the remaining balance of the sums due on the four promissory notes has been paid in full.
