### Collateral Description:

The term "collateral" in this financing statement shall not include "Excluded Collateral" as hereinafter defined and the Secured Party hereby releases all right, title, and interest in and to the Excluded Collateral, to the extent that Secured Party has any interest, past, present or future in the Excluded Collateral wherever located, whether now owned, assigned or pledged, or hereinafter created, assigned or pledged, by Debtor to Narragansett Electric Company ("Narragansett Electric") under the terms of a separate security agreement, as may be amended, modified or altered from time to time, by and between the Debtor and Narragansett Electric, commonly referred to as the "Competitive Electric Supplier Service Agreement for Billing Services and for the Purchase of Accounts Receivable ( the "Supplier Services Agreement").

Debtor has granted or will grant to Narragansett Electric a continuing security interest in and to the following (the "Excluded Collateral").

All of the Debtor's accounts and general intangibles consisting of amounts due or to become due from the Debtor's electric customers, which are purchased or to be purchased from the Debtor by Narragansett Electric pursuant to the Supplier Services Agreement. Without limiting the foregoing, the Excluded Collateral shall specifically include the following:

- All Accounts Receivable (as such term is defined in the Supplier Services Agreement) purchased by Narragansett Electric under the Supplier Services Agreement; and
- All Unbilled Accounts Receivable (as such term is defined in the Supplier Services Agreement) to be purchased by Narragansett Electric under the Supplier Services Agreement.
