The term "collateral" in this financing statement shall not include "Collateral" as hereinafter described and the Secured Party hereby releases all right, title and interest in and to the Collateral, to the extent that Secured Party has any interest, past, present or future in the Collateral wherever located, whether now owned or assigned or pledged, or hereinafter created, assigned or pledged, by Debtor to Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") under the terms of a separate security agreement, as may be amended, modified or altered from time to time, by and between the Debtor and National Grid, commonly referred to as the "Agreement for Billing Services for the Purchase of Electric Accounts Receivable" ("Agreement"). Debtor has assigned or granted or will assign or grant to National Grid a continuing security interest in and to the following Collateral: (a) all Accounts Receivable, as such term is defined in the Agreement, purchased and billed and reflected on consolidated bills by National Grid under the terms of the Agreement; (b) the Deposit as such term is defined under the Agreement and (c) all Unbilled Accounts Receivable, as such term is defined in the Agreement, purchased by National Grid under the terms of the Agreement.
